1. For good and valuable consideration, receipt of which is hereby acknowledged, I authorize CarrascoMediaGroup. ("Producer") to make use of my appearance in connection with that certain television series tentatively entitled "The Dr Carrasco Show, Doctor2Patients" (the "Series"), to be produced by Producer. I acknowledge and agree that I am not entitled to any compensation in connection with my appearance in the Series.

2. I understand that I may be filmed, videotaped, sound recorded and/or photographed in connection with my participation in the taping of the Series and any such films, videotapes, sound recordings and photographs (collectively, the "Material") may include my name, voice and/or actual or simulated likeness. I hereby consent to Producer's use of my photograph, name, voice, and/or actual or simulated likeness in connection with the production, distribution, broadcast, exhibition, advertising and exploitation of the Series and elements thereof, in any and all media now known or hereafter devised, throughout the universe in perpetuity. I hereby waive any right of inspection or approval of the Material or the uses to which such Material may be put. I acknowledge that Producer is not obligated to actually produce the Series or include the Material in the Series for which it was shot or otherwise.

3. I acknowledge that Producer will rely on the permissions granted herein and I hereby agree not to assert any claim of any nature whatsoever against anyone relating to the exercise of the permissions granted hereunder, including without limitation the use of the Material, the use of my name, voice and/or likeness in the Material and/or Producer's and/or the applicable television network or cable broadcaster's ("Network") decision not to use my name, voice and/or likeness in the Material and/or the decision not to use the Material in the Series. I hereby release Producer and the Network from any and all claims, demands or causes of action which I and/or my heirs, successors, or assigns may now have or hereafter acquire by reason of Producer's and/or the Network's exercise of the rights herein granted. I hereby waive any and all claims of defamation and "false light", violation of rights of privacy and/or publicity, and/or any other rights of a similar or dissimilar nature in connection with the distribution and exploitation of the Material and I hereby agree not to assert any claim of any nature whatsoever against any party related to the subject matter hereof. In such regard, I waive any rights I hereby agree to and do hereby indemnify and hold harmless Producer from and against any breach of this Release by me and/or any claim, action, proceeding, and/or demand brought, maintained, prosecuted or made by or through me and from and against any and all loss, cost, damage and/or expense incurred by Producer in connection therewith, including, but not limited to attorneys' fees and costs.

4. I represent and warrant that I understand that, it is a federal offense, unless disclosed to Producer or the Network prior to broadcast to: (i) give or agree to give any member of the production staff, anyone associated in any manner with the Series, or any representative of the Network, anything of value for arranging for my appearance in the Series; or (ii) accept or agree to accept anything of value to promote any product, service or venture on the air, or use any prepared material containing such a promotion where I have received consideration for it. I acknowledge that I am aware that it is Producer's policy not to permit the acceptance or payment of any such consideration and that any such acceptance of payment shall constitute a material breach of this Release. In accordance therewith, but not as limitation thereon, I expressly represent that I have not accepted or paid, and I agree not to accept, pay or agree to accept or pay, any such consideration.

5. I acknowledge that Producer may be incurring substantial sums in reliance on the permissions granted herein and I shall in no event be entitled to rescind or terminate this Release or any of the rights granted hereunder, or to seek same, or to interfere with, restrain, enjoin or otherwise impair the development, production, exhibition, distribution, promotion, advertising or other exploitation of the Series, or any other productions, or the use of the Material, and my sole remedy in any or all cases and in connection with any claims shall be an action at law for actual money damages, if any.

6. I understand that in connection with my participation in the taping of the Series, I may be provided with or otherwise obtain "Confidential Information" (as such term is defined below). I understand and acknowledge that Producer has strict policies with regard to the dissemination of Confidential Information. In consideration of Producer's agreement to allow me to participate in the taping of the Series, I agree to hold confidential and not disclose at any time to the public, the media or to any person or entity, any Confidential Information. For the purposes hereof, "Confidential Information" shall be defined as any information or materials of any kind concerning or relating to the Series, including, without limitation, any participants in the Series, the location(s) of the Series, the events contained in the Series, or the outcome of any contest in or episode of the Series (including without limitation the results of so-called "eliminations" of episodes of the Series which may not yet have been broadcast), that I read, hear, or otherwise acquire or learn in connection with or as a result of my participation in the taping of the Series or otherwise (collectively, the "Confidential Information").

7. I acknowledge and agree that: (1) the Confidential Information is proprietary to and commercially and competitively valuable to Producer; (2) a breach by me of this Release, including without limitation the confidentiality provision, would cause Producer irreparable injury and damage that that cannot be reasonably or adequately compensated by money damages in an action at law, and therefore, I hereby expressly agree that Producer shall be entitled to injunctive and other equitable relief to prevent and/or cure any breach or threatened breach of this Release by me; (3) proof of damages suffered by Producer in the event that I breach this Release will be costly, difficult, or inconvenient; (4) One Million Dollars (\$1,000,000) is a reasonable estimate of the amount of damages that Producer is likely to suffer in the event I breach this Release, considering all of the circumstances existing as of the date of this Release; (5) by this Release, Producer is taking reasonable steps to protect its legitimate interests in its Confidential Information; (6) the rights and obligations of the parties under this Release may be enforced by a decree of specific performance issued by a court of competent jurisdiction without Producer posting any bond and such remedy shall not prohibit Producer from pursuing any other remedy, whether at law or in equity, available to Producer for a breach or threatened breach of this Release, including, without limitation, recovery of money damages from me, disgorgement of the monies or other consideration received by me, if any, in connection with any disclosure, and the recovery of any and all of Producer's attorneys' fees and costs incurred to enforce this. Accordingly, I agree to pay Producer the sum of One Million Dollars (\$1,000,000) per breach as liquidated damages in the event that I breach any term of this Release.

8. I represent and warrant that I am not a member of AFTRA, SAG, Equity, or any other guild or trade union associated with the performing arts and that my involvement hereunder is as a member of the public and that I am only appearing as myself and I am not portraying a role or character as an actor or an extra..

9. This Release shall be governed by and construed under the internal substantive laws of the State of California applicable to contracts wholly executed and performed therein. This Release shall be binding upon me and my heirs, successors, licensees and assigns forever and shall be freely assignable by Producer. This Release sets forth the entire understanding of the parties with respect to the subject matter hereof, and may not be modified except by a writing signed by me and Producer.
